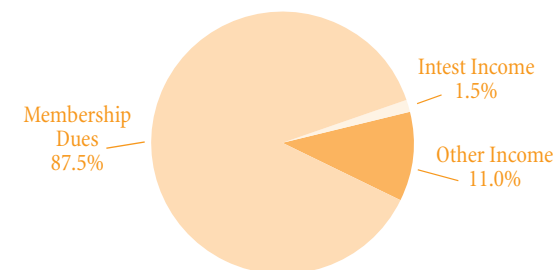

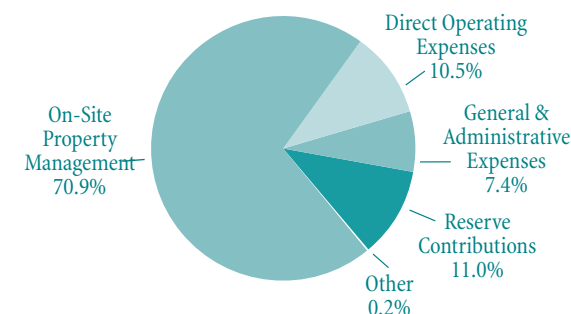

The Sea Of Cortez Called The Most Productive Water In The World

The spectacular Cabo Pulmo National Marine Park is located about 40 miles north of San Jose del Cabo on the eastern cape of Baja, “the interactive peninsula”. The abundant coral growth on the rocky reef provides shelter and food for countless colorful reef fish, many of which are found nowhere else in the world. This nutrient-rich water results in a profusion of plankton that forms the base of a vast food web of invertebrates, fish, birds and mammals making the Sea of Cortez one of the most productive waters in the world.

Doctor On-Site at Villa del Palmar!

Dr. Andres Flores has been our house doctor for several years now. He was available on-call 24 hours a day, and he still is, but now he is actually on-site at the resort with office hours Monday through Saturday, 9 a.m. to 9 p.m. His clinic is located right at the Villa’s Plaza. For emergencies and more involved procedures, the hospital is five minutes away from the resort. There is also ambulance service. Hopefully you will not need his attention, but if you do, rest assured that you are in good hands. We know this will make your vacation even more care free.

The reef is the only hard coral reef found in the Sea of Cortez. It is one of only three living reefs in North America. A Mexican fishing vessel (the Colima), sunk here during a storm in 1939. It now lies in 15 meters of water approximately 2.4 kilometers north of Punta Cabo Pulmo. This offers the added bonus of a wreck dive for scuba enthusiasts to an already fascinating marine park.
